# VILLAGE OF TRUMANSBURG LOCAL LAW NO. 3 - 2020 AMENDMENT OF LOCAL LAW NO. 4 - 2019 "MOTOR VEHICLE & TRAFFIC" LAW

Be it enacted by the Board of Trustees of the Village of Trumansburg as follows:

#### SECTION I PURPOSE AND INTENT

It is the purpose and intent of this Proposed Local Law to amendLocal Law 4 of the Year 2019 "Motor Vehicle & Traffic", of the Village of Trumansburg so as to move the loading zone on East Main Street from its current location to the space in front of the Masonic Temple.

#### **SECTION II AUTHORITY**

This Local Law is enacted pursuant to the grant of powers to local governments provided for in Section 10 of the Municipal Home Rule Law to adopt and amend local laws not inconsistent with the provisions of the New York State Constitution or not inconsistent with any general law relating to its property, affairs, government or other subjects provided for in said Section 10 of the Municipal Home Rule Law.

# SECTION III AMENDMENT OF LOCAL LAW 4 - 2019 "MOTOR VEHICLE & TRAFFIC" LAW

As of the effective date of this Local Law, the current and existing Local Law No. 4 - 2019, will be amended by the following, it being intended thereby to promote the health, comfort, safety and welfare of all persons in the Village, and promulgate rules and regulations to govern the aforementioned:

Amendment of to the Local Law No. 4 - 2019 "Motor Vehicle & Traffic" Law:

#### Section A.1 of "Truck Loading Zones" shall be updated as follows:

(EXISTING) On the north side of East Main Street from the west curb line for the alley between Number 55 and 59 East Main Street extending westerly for 46 feet.

(NEW) On the north side of East Main Street from the west curb line for the alley between Number 55 and 59 East Main Street extending westerly for 23 feet, and on the north side of East Main Street from the east curb line for the alley between Number 55 and 59 East Main Street extending easterly for 23 feet.

### SECTION IV SUPERSEDING EFFECT

All Local Laws, resolutions, rules, regulations and other enactments of the Village of Trumansburg in conflict with the provisions of this Local Law are hereby superseded to the extent necessary to give this Local Law full force and effect.

#### SECTION V VALIDITY

The invalidity of any provision of this Local Law shall not affect the validity of any other provision of this Local Law that can be given effect without such invalid provision.

## SECTION VI <u>EFFECTIVE DATE</u>

This Local Law shall be effective as of the date of filing with the New York Secretary of State, except that it shall be effective from the date of service as against a person served with a copy thereof, certified by the Village Clerk, and showing the date of its passage and entry in the Minutes of the Village Board of Trustees.
