Scheduling of a Public Hearing Notice
Apply for the Community Development Block Grant

The Town of Hopewell will hold a public hearing on June 22, 2022 at 7PM at the Hopewell Town Hall located at 2716 County Road 47, Canandaigua, NY 14424 for the purpose of hearing public comments on the Town of Hopewell's community development needs, and to discuss the possible submission of one or more Community Development Block Grant (CDBG) applications for the 2022 program year. The CDBG program is administered by the New York State Office of Community Renewal (OCR), and will make available to eligible local governments approximately \$633,675.00 for the 2022 program year for housing, economic development, public facilities, public infrastructure, and planning activities, with the principal purpose of benefitting low/moderate income persons. The hearing will provide further information about the CDBG program and will allow for citizen participation in the development of any proposed grant applications and/or to provide technical assistance to develop alternate proposals. Comments on the CDBG program or proposed project(s) will be received at this time. The hearing is being conducted pursuant to Section 570.486, Subpart I of the CFR and in compliance with the requirements of the Housing and Community Development Act of 1974, as amended. The Hopewell Town Hall is accessible to persons with disabilities. If special accommodations are needed for persons with disabilities, those with hearing impairments, or those in need of translation from English, those individuals should contact Town Clerk Denise L. Service Truck with body \$54,401.50(replace the 14 year old truck /over 190,000 miles on it)

2022 Ford F-350 XLT Super Cab 4x4 & Service Body

Dump Truck \$96,096.80

2022 Ford F-750 Regular Cab Diesel

WHEREAS, the following is the breakdown of the funds including inflation:

Water District 1- \$40,635.00

Water District 2- \$25,585.00

Water District 3- \$72,239.00

Water District 4- \$ 6,772.00

Water District 6- \$ 5,267.30

WHEREAS, this is per Resolution from December 30, 1992, which states that, pursuant to Section 6-C of the General Municipal Law, as amended, this Hopewell Town Board does hereby establish a Capital Reserve Fund to finance the cost of acquisition of Water Districts Machinery as monies are shown in the budget. No expenditures shall be made from this fund, except upon authorization of the Board pursuant to 6-C of the General Municipal Law.

NOW, THEREFORE, BE IT RESOLVED, that the Hopewell Town Board authorizes the Town of Hopewell Bookkeeper to transfer \$150,498.30 from SW231 Special Reserve Machine Fund to SW8340.2 Transmission and Distribution Equipment. This resolution shall be subject to a permissive referendum, as required by law.

RESOLUTION#14-2022
AUTHORIZING ACCEPTANCE OF WATER EASEMENTS

WHEREAS, the Town of Hopewell, by its officers or representatives, has engaged in discussions with **Jay Ladue, LLC**, regarding the Town obtaining water and utility easements from it over a portion of its premises and portions of premises owned by others to which Jay Ladue, LLC retained the rights to grant such easements to the Town, all located in the Lincoln Hill Subdivision in the Town of Hopewell and with **Michael Uvanni** regarding the Town's obtaining a water and utility easement from him over a portion of his premises located in the Lincoln Hill Subdivision in the Town of Hopewell, said properties identified as follows:

1. Lot 3 with a Tax Map No. 99.00-1-44.113 owned by Colleen A. Schreiner and Frederick G. Schreiner, with Jay Ladue, LLC reserving the right to grant water and utility easements to the Town of Hopewell;
2. Lot 4 with a Tax Map No. 99.00-1-44.114 owned by Michael Uvanni;
3. Lot 5 with a Tax Map No. 99.00-1-44.115 owned by Scott J. Rohr, with Jay Ladue, LLC reserving the right to grant water and utility easements to the Town of Hopewell;
4. Lot 6 with a Tax Map No. 99.00-1-44.116 owned by Frank H. Hamlin, III and Debra A. Hamlin, with Jay Ladue, LLC reserving the right to grant water and utility easements to the Town of Hopewell.

WHEREAS, Town of Hopewell officials have recommended to the Town Board that Jay Ladue, LLC, for itself and on behalf of the owners of Lots 3, 5 and 6 of the Lincoln Hill Subdivision, and that Michael Uvanni each grant to the Town certain water easements over said lands aforesaid for water purposes; and

WHEREAS, said easements have been offered by Jay Ladue, LLC and Michael Uvanni to the Town of Hopewell; and

WHEREAS, the Town Board of the Town of Hopewell is desirous of accepting said offered water easements; and

WHEREAS, the Town Board of the Town of Hopewell has examined said instruments and finds the consideration described therein to be fair and reasonable.

NOW, THEREFORE, BE IT RESOLVED that the Town Board of the Town of Hopewell does hereby accept the Easements attached hereto as Exhibits A, B, C and D in accordance with the terms and conditions in said instruments and directs that the same be recorded in the Office of the Clerk of the County of Ontario, the fees for said recording to be borne by Jay Ladue, LLC; and

BE IT FURTHER RESOLVED that the Supervisor of the Town of Hopewell is authorized to execute the easements and any other documents necessary to effectuate the conveyances and recording of said easements.
