LOCAL LAW NO. 3- 2025 AMENDMENT OF LOCAL LAW NO. 4 – 2019 "MOTOR VEHICLE & TRAFFIC" LAW

Be it enacted by the Board of Trustees of the Village of Trumansburg as follows:

SECTION I PURPOSE AND INTENT

It is the purpose and intent of this Proposed Local Law to amend Local Law 4 of the Year 2019 "Motor Vehicle & Traffic", of the Village of Trumansburg, so as to alter parking restrictions on Union Street, to allow for parking on the south/east side of the street, and prohibit parking on the north/west side of the street along the sidewalk by the Trumansburg Conservatory of Fine Arts.

SECTION II <u>AUTHORITY</u>

This Local Law is enacted pursuant to the grant of powers to local governments provided for in Section 10 of the Municipal Home Rule Law to adopt and amend local laws not inconsistent with the provisions of the New York State Constitution or not inconsistent with any general law relating to its property, affairs, government or other subjects provided for in said Section 10 of the Municipal Home Rule Law.

SECTION III <u>AMENDMENT OF LOCAL LAW 4 – 2019</u> "MOTOR VEHICLE & TRAFFIC" LAW

As of the effective date of this Local Law, the current and existing Local Law No. 4 - 2019, will be amended by the following, it being intended thereby to promote the health, comfort, safety and welfare of all persons in the Village, and promulgate rules and regulations to govern the aforementioned:

Amendment of to the Local Law No. 4 – 2019 "Motor Vehicle & Traffic" Law:

Section D.1 of "Parking Prohibitions" shall be updated as follows:

(EXISTING) On the south side of Union Street from the southerly curb line of Cayuga Street to a point 115 feet northerly from the northerly curb line of MainStreet

(NEW) On the westerly side of Union Street between the most northerly corner of tax parcel 2.-5-5 and the southerly curb line of Congress Street.

SECTION IV SUPERSEDING EFFECT

All Local Laws, resolutions, rules, regulations and other enactments of the Village of Trumansburg in conflict with the provisions of this Local Law are hereby superseded to the extent necessary to give this Local Law full force and effect.

SECTION V VALIDITY

The invalidity of any provision of this Local Law shall not affect the validity of any other provision of this Local Law that can be given effect without such invalid provision.

SECTION VI EFFECTIVE DATE

This Local Law shall be effective as of the date of filing with the New York Secretary of State, except that it shall be effective from the date of service as against a person served with a copy thereof, certified by the Village Clerk, and showing the date of its passage and entry in the Minutes of the Village Board of Trustees.
