New Business

Updates by Town Officials

Town Clerk-Denise Hood

To date, 81% of the Town and County Taxes have been collected. The Town of Hopewell will pay Ontario County a second payment in the beginning of March. Town Clerk Hood received correspondence from Hopewell Town Assessor, Kelly Ducar indicating that the 2015 tentative assessment roll has reached its retention period of five years and it can be destroyed. Also, any exemption applications that were denied or sold from the year 2014 can be destroyed as they have reached their six year retention period. Also, as of today the Hopewell Extension #3 vouchers will begin on Voucher number #3042.

Highway Superintendent-Matt Curran

Highway Superintendent Curran stated the New Truck has arrived, but the paperwork is pending. The highway staff is putting the truck together. Truck #3 will be going into surplus when the new truck is in service.

Highway Superintendent Curran attended the New York State Association for Highway Superintendents. There were 900 in attendance. At that time they discussed Advocacy Day, pension and barter for more State Healthcare.

Water Superintendent-Ken Potter

Water Superintendent Ken Potter noted they have received notification from the City of Canandaigua of the new Water rate for 2020. Last fall the projected rate was to be \$2.086 per 1,000 gallons, a .12 cent increase. The final rate is now \$2.01434/1,000 gallon, a .05 cent increase.

The Water rate from the Town of Gorham remains stable at \$2.98 per 1,000 gals. The rate from the Town of Seneca is \$2.75.

Water Superintendent Potter had started the 2019 Annual Water Quality Reports for both the Canandaigua and Gorham reports. If there is anything the Board would like to add, please let him know as soon as possible.

Water Superintendent Potter noted they have started working with the Ontario County DPW and Bergmann Engineers on the Roundabout for County Road 46 and Smith Road. The current design will require substantial Water main relocation on three sides of the intersection. This intersection has become a critical asset to our chlorine distribution from the tank with the addition of Extension #3 Water District. We will need to create a means to keep the existing piping in service and transition to new with a minimum of disruption.

Resolution #5-2020 Resolution and order approving an increase in the maximum amount to be expended for improvements in the Town of Hopewell Central Water District Extension No. 4.
